TERMS AND CONDITIONS

Tentative Holds

Once availability is confirmed we can hold your reservation tentatively for 3 days, commitment free. Tentative holds are placed on request only. Philter Brewing Pty Ltd reserves the right to release tentative reservations if confirmation and deposit payment are not received within this period.

Reservation Confirmations & Holding Deposit

To secure your booking, your confirmation and \$1000.00 holding deposit are required within 5 business days following your enquiry. Reservations are not deemed secured until the deposit is paid.

This holding deposit secures your reservation and will be redeemable against the final bill at the end of your function.

Minimum Spend

Private functions will be subject to a minimum spend. The minimum spend amount is variable depending on the date of the event request and will cover the venue hire and food & beverage costs. The minimum spend is for the booked event only and is not transferable to any other Philter Brewing Pty Ltd products or services.

Cancellations

Cancellation requests must be provided in writing.

If your group reservation is cancelled within 7 days of the reservation date, the holding deposit will not be refunded and will be deemed non-transferable.

Date Transfers

Transfer requests must be provided in writing.

Reservations may be transferred at least 2 weeks prior to the date at no extra charge subject to availability

If the transfer occurs within 2 weeks of the reservation date a \$15 per head transfer fee will be charged to the card provided at the time of booking.

Please note there is no option to transfer the date within 48 hours of the reservation. This will be treated as a cancellation.

Pricing

Pricing is GST inclusive. Please note all credit card / debit card transactions incur a 0.9% processing fee.

Final Guest Numbers

Final guest numbers must be confirmed no later than 10 business days prior to event reservation.

Maximum Guest Numbers

Philter Public Bar & Restaurant can accommodate a maximum of 120 guests for a group reservation. Marrickville Springs can accommodate a maximum of 50 guests for a group reservation. Maximum

guest numbers are subject to any government advice, management approval and a minimum spend will apply. This must be confirmed with your Reservation Coordinator.

Music/Entertainment/Decorations

Due to our licensing conditions, additional decorations or entertainment activities are subject to approval prior to booking.

Damages

The client is financially liable for any damage to restaurant property through their own actions or the actions of their guests. No confetti-like decoration is permitted (confetti, rice, rose petals, sand, etc.).

Personal Belongings
